3 Resolution amending the Landmark Tree Nomination Form used in the implementation of the  
4 nomination and evaluation process for landmark trees in the City and County of San Francisco.

5 WHEREAS, The Environment Code, Chapter 12, Section 1203 charges the Urban  
6 Forestry Council with developing criteria for a landmark tree program for the City and County of  
7 San Francisco; and,

8 WHEREAS, The Board of Supervisors passed **Ordinance 0017-06 Amendment to**  
9 **Public Works Code - Section 801, Landmark Trees, Significant Trees, and Penalties for**  
10 **Violations** on January 20, 2006, which directs the Council to implement a landmark tree  
11 program that includes a nomination and evaluation process; now, therefore be it,

12 RESOLVED, That the Urban Forestry Council has amended and approved the landmark  
13 tree nomination form used in the implementation of the nomination and evaluation process for  
14 landmark trees in the City and County of San Francisco at its meeting on August 28, 2012, and,  
15 be it,

16 FURTHER RESOLVED, That the Council has further amended and approved the  
17 landmark tree nomination form used in the implementation of the nomination and evaluation  
18 process for landmark trees in the City and County of San Francisco at its meeting on January  
19 25, 2013, and that the Council will submit these amended documents to the Board of  
20 Supervisors.

Who can nominate a landmark tree?

- The Board of Supervisors, Planning Commission, and the Historic Preservation Commission may nominate a tree.
The head of a City department or agency may nominate a tree on property under their jurisdiction. City departments and agencies should conduct an internal approval process before nominating a tree.
Property owners may nominate a tree on their property.
A member of the public may ask an authorized nominator to nominate a tree.

Please note that a permit will be required for any future removal of a landmark tree.

The decision to designate a landmark tree takes into consideration the following qualities:

- (1) **Structure/physical characteristics** The tree presents a structural or physical presence that is exceptional. Also includes the age, size, or rarity of the tree. The overall health and condition of the tree is considered.
- (2) **Ecological interaction and contribution** The ecological contribution of the tree is exceptional or the tree positively affects the surrounding environment in a superlative manner, including: If the tree is part of an interdependent group of trees or exists in an area with low tree density; or if it provides important wildlife habitat or environmental mitigation.
- (3) **Cultural or historical value** The noteworthy cultural or historical value of the tree including: If it reflects the character or a unique time or event in the history of the neighborhood or the city; if it is of particular value to certain cultural or ethnic groups in the city; if it contributes significantly to or is representative of neighborhood character. Includes accessibility and utility to the public.
- (4) **Aesthetic contribution** The extraordinary aesthetic qualities of the tree including: If the tree is visible or accessible from public property; if the tree is of distinguished form or is a good example of form for its species; if the tree has a majestic or otherwise unique structure; if it is a prominent landscape feature.

**Any information you submit will be part of the public record.**

The Public Records Act defines a "public record" broadly to include "any writing containing information relating to the conduct of the public's business prepared, owned, used or retained by any state or local agency, regardless of the physical form or characteristics." Govt. Code § 6252(e). The Sunshine Ordinance defines "public information" as the content of "public records" as defined in the Public Records Act. Admin Code § 67.20(b). Pursuant to the Public Records Act and Sunshine Ordinance, this document is a public record and will be available to the public upon request, at the hearing site, at the San Francisco Main Library, and on the Urban Forestry Council's website. Admin Code §§ 8.16, 67.7 (b), and 67.21(a).
