### Who can nominate a landmark grove?

- The Board of Supervisors, Planning Commission, and Historic Preservation Commission.
- The head of a City department or agency may nominate a grove on property under their jurisdiction.
- Property owners may nominate a grove on their property.
- A member of the public may ask an authorized nominator to nominate a grove.

**Please note that you will be required to submit a management plan with this application. Any tree removal, tree planting, or tree pruning, or major landscaping work within Landmark Grove boundaries must gain approval of Department of Public Works, which will make determinations based on the approved management plan.**

**A grove is defined as three or more trees that function together ecologically, culturally, or aesthetically. The decision to designate a group of trees as a landmark grove takes into consideration the following qualities:**

- (1) **Structural/physical characteristics** The age, size, or species of the trees, particularly whether they exhibit exceptional characteristics in this regard;
- (2) **Ecological interaction and contribution** including whether they function together to provide an ecological contribution notably greater than the sum of the parts or whether their natural processes are inextricably linked to each other, and whether this interaction is of exceptional value to the city;
- (3) **Cultural or historical value** The noteworthy cultural or historical value of the grove including: If it reflects the character or a unique time or event in the history of the neighborhood or the city; if it is of particular value to certain cultural or ethnic groups in the city; if it contributes significantly to or is representative of neighborhood character.
- (4) **Aesthetic contribution** The extraordinary aesthetic qualities of the grove including: including whether or not the trees function together to create a "sense of place," that is, a unique or distinct visual character of extraordinary quality.

The management plan should include routine maintenance activities, pruning guidelines and frequency, parameters to make determinations on future tree removal, when trees will be planted within the grove, which species will be planted or how species will be chosen and how future planting locations will be determined, and parameters for tree protection planning for any future major landscaping work.
