- Task Force membership has changed: Melissa Higbee has been appointed to represent the Office of Resilience and Capital Planning. Anthony Bernheim has resigned as Public Member since he is now SFO staff. Chair suggested that Emilie Hagen, another candidate submitted in Fall 2017 to the Mayor's Office for consideration, be recommended for the new Public Member vacancy. There were no objections.

 scope of work was insufficient to constitute a Tenant Improvements project per Municipal Green Building Code
