ORDER OF BUSINESS

Public comment will be taken before the Committee takes action on any item.

1. Call to Order and Roll Call.

The Commission on the Environment Operations Committee meeting was called to order at 5:06 p.m.

Present: Commissioners Stephenson, Chu and Wan.

2. Approval of Minutes of the October 16, 2019 Commission on the Environment Operations Committee Meeting. (Explanatory Document: October 16, 2019 Draft Minutes) (Discussion and Action)

Commissioner Stephenson pointed out a date typo in the agenda for this item.

Upon a motion by Commissioner Chu, and a second by Commissioner Wan, the minutes were approved without objection. (Ayes: Commissioners Stephenson, Chu and Wan. Noes: None)

There was no public comment.

3. General Public Comment. Members of the public may address the Committee on matters that are within the Committee's jurisdiction and are not on today's agenda.

There was no public comment.

4. Vote to recommend that the Commission on the Environment approve the proposed Department of the Environment Fiscal Year 2020-21 and 2021-22 Budget. Sponsor: Jennifer Kass, Deputy Director; Speaker: Joseph Salem, Program Manager, Finance and Administration (Explanatory Document: Draft Department of the Environment Fiscal Year 2020-21

and 2021-22 Budget) (Discussion and possible vote on whether to recommend that the Commission on the Environment approve the proposed Department of the Environment Fiscal Year 2020-21 and 2021-22 Budget.)

Joseph Salem, Program Manager, Finance and Administration, discussed the draft budget, office lease, city deficit, department deficit, grant loss and gave a detailed overview of each program budget pointing out the largest deficit in the energy program. Next, there was a comparison of revenue and expenditures between 2019-2020 and 2020-2021 budget. To balance the budget the Department will be looking for ways to decrease expenditures and increase revenue.

Jennifer Kass, Deputy Director, discussed criteria for office relocation and lease information.

Commissioner Stephenson asked if the one-time cost associated with the move is included in the budget.

Jennifer Kass explained that the cost of moving is not part of operational costs.

Commissioner Wan asked if the length of the lease is factored into the operational costs.

Jennifer Kass explained that it is.

Commissioner Stephenson discussed historical budget trends and asked about potential grants.

Jennifer Kass discussed the state of grants.

Joseph Salem discussed which grants were included in the budget.

Commissioner Stephenson asked for more information about nonpersonal service cuts.

Joseph Salem explained these cuts.

Commissioner Wan asked about the funds for the one-time relocation cost.

Joseph Salem explained that reserve funds can be allocated to these costs.

Jennifer Kass discussed the reserve fund functionality.

Commissioner Wan asked about how much is available in the reserve fund.

Jennifer Kass discussed a need to determine moving costs first.

Joseph Salem discussed the money available in reserve.

Commissioner Stephenson discussed allocation of these funds.

Commissioner Wan asked if the end of the Energy Watch Grant was anticipated.

Jennifer Kass discussed the state of funding and grants for energy efficiency services.

Commissioner Stephenson asked about the length of lease.

Jennifer Kass said the terms of the lease are in negotiation.

Commissioner Stephenson expressed interest in long-term leases to avoid multiple instances of moving costs.

Commissioner Chu asked if there is any way to prioritize activities based on grants opportunity forecasting.

Jennifer Kass discussed that the Department is always looking ahead at opportunities.

Commissioner Wan discussed approval of the budget and hesitations with the deficit.

Jennifer Kass explained that this is the beginning of the budget draft process and that this is not an uncommon part of the process.

Commissioner Wan asked about a hiring freeze.

Jennifer Kass discussed hypothetical potentials for budget cuts.

Commissioner Stephenson discussed program budget allocation.

Joseph Salem discussed upcoming schedule related to the budget.

There was no public comment.

Upon a motion by Commissioner Wan, and a second by Commissioner Chu, the motion passes without objection. (Ayes: Commissioners Stephenson, Chu and Wan. Noes: None)

5. Presentation on new initiatives for the Green Business Program. Speaker: Kevin Kumataka, Green Business Representative (Discussion)

Kevin Kumataka, Green Business Representative, provided an overview of Green Business Program including standards, outreach, business assistance, partnership with the California Green Business Network, checklist guidelines, business rewards, partnership with Department of Public Health, green business awards, three-tiered recognition program, cost saving opportunities, pollution prevention measures, partnership with Public Utilities Commission, employee engagement, cost-saving benefits for participants, pre-bate programs, logo certification, social media promotion, signed certificates, award plaques, advertising, and face-to-face targeted outreach.

Commissioner Wan asked about property manager roles.

Kevin Kumataka discussed information they provide to property managers and flexibility to work with businesses on what they can control.

Commissioner Stephenson suggested combining efforts of the outreach team with green business outreach.

Kevin Kumataka discussed referrals from the energy watch team and Department of Public Health.

Commissioner Chu asked about goals for the number of enrolled businesses.

Kevin Kumataka discussed reaching 100 enrolled businesses and an interest in increasing quality over quantity.

Commissioner Stephenson asked about recertification and updated standards.

Kevin Kumataka discussed that the team conducts recertification.

Commissioner Wan asked about business target goals.

Kevin Kumataka discussed targeting businesses that consumers are interested in and helping struggling businesses.

Commissioner Wan asked about business chamber outreach.

Kevin Kumataka discussed presentations at merchant associations.

There was no public comment.

6. Presentation on Outreach for the Used Oil Program. Speaker: Huy Le, Household Hazardous Waste & Used Oil Program Coordinator (Discussion)

Huy Le, Household Hazardous Waste & Used Oil Program Coordinator, discussed program history, funding, oil collection locations, study on oil disposal, community focus groups, outreach campaigns targeting Chinese and Latino communities, projects related to equity, and noted the launch of the 2020 outreach campaign.

Commissioner Wan complimented the campaigns.

Commissioner Stephenson asked for details of the 2020 campaign including budget and target outreach numbers.

Huy Le discussed post-surveys on recycling rates.

Commissioner Stephenson discussed self-reporting post-survey.

Commissioner Chu asked about the magnitude of the improperly disposed oil problem.

Huy Le discussed the magnitude of the problem.

There was no public comment.

7. New Business/Future Agenda Items. Charles Sheehan, Policy and Communications Director

Charles Sheehan, Policy and Communications Director, discussed the upcoming meeting schedule and potential upcoming presentations.

1. Briefly responding to statements made or questions posed by members of the public, or
2. Request staff to report back on a matter at a subsequent meeting, or
3. Directing staff to place the item or issue on a future agenda (Government Code Section 54954.2(a).)
