1. Welcome
2. Minutes: The meeting minutes from January 10, 2018 were adopted as written.
3. Green Building Announcements:
 - There are two new LEED certified municipal projects: Congratulations to project teams for Diane B Wilsey Center for Opera and Bayview Plaza. Both projects earned LEED ID+C Gold certification. There are now 57 LEED certified municipal projects totaling 7,670,326 sf. *(Note: the distributed list of certified municipal projects erroneously included three City College sites that have since been removed – a corrected list is attached)*
 - The GS-6 submittal form has been updated to include the Wiring for EV Charging requirement. It is now posted on the DBI website.
 - Daniel Alvarado has been appointed to represent SFPUC Infrastructure on the Task Force.
4. Presentation: Peter Brastow, SF Environment's Senior Biodiversity Coordinator, shared current efforts by the City to integrate biodiversity throughout the built environment.
5. Old Business: Implementation of the Municipal Green Building Code (Environment Code Chapter 7) for "small projects" was reviewed. The Task Force provided additional feedback for consideration.
6. New Business: A draft summary characterizing Alternate Compliance in Municipal Green Building Code was reviewed, including a proposed crosswalk for using Envision Rating System for Sustainable Infrastructure. The Task Force provided feedback for consideration.
7. Public Comment: None.
