Order of Business

Public comment will be taken before the Council takes action on any item.

1. Call to Order and Roll Call

The meeting was called to order at 4:02 pm.

Present: Chair Igor Lacan, Members Dan Flanagan, Blake Troxel, Nicholas Crawford and Andrew Sullivan.

2. Approval of Minutes of the March 2, 2021 Urban Forestry Council Planning and Funding Committee Meeting. (Explanatory Document: March 2, 2021 Draft Meeting Minutes)(Discussion and Action)

Upon a motion by member Crawford and a second by Chair Lacan, the amended minutes were approved without objection. (Ayes: Chair Igor Lacan, Nicholas Crawford, Blake Troxel, Dan Flanagan and Andrew Sullivan. Noes: None. Excused: None. Absent: None.)

Member Crawford suggested a revision to the draft minutes by deleting one of the sentences under agenda item 4.

There was no public comment.

3. General Public Comment: Members of the public may address the Committee on matters that are within the Committee's jurisdiction and are not on today's agenda.

There was no public comment.

4. Discussion of the Annual Urban Forest Report. (Explanatory Document: 2020 Annual Urban Forest Report)(Discussion and Possible Action)

Chair Igor Lacan stated that he would like the group to give the Annual Report one last look and mentioned that he is fine with the current version.

Peter Brastow stated that survey questions around tree planting could be clarified, and that following up with individuals who report on planting for more specifics could be done. More detailed questions around the plant species in the Maintenance question could be added. Discussion occurred about what kind of information the Committee wanted to gather. Member Crawford mentioned that COVID-19 stay-at-home orders halted pruning and only allowed for removal of trees, limiting overall maintenance progress this year.

The following ideas were discussed for the planting question section of the report:

- To add check-boxes to the form in order to gather specific data;
- Recording tree size;
- A possible method for distinguishing between street trees and other planted areas (built environment, open-spaces, etc.) within the report.

Chair Lacan urged the group to keep thinking about how best to approach the question of gathering this data.

There was no public comment.

5. Discussion of priorities for Urban Forestry Council review of development projects. (Discussion and Possible Action)

Peter Brastow reviewed draft guidelines for what projects should include when making a presentation to the Urban Forestry Council.

The committee discussed alignment with the Urban Forestry Plan as part of project review. Member Troxel suggested matching the checklist to the priority goals in the Urban Forest Plan. Discussion ensued regarding which parts of the plan would apply such as the Growth, Protection and Management strategies and which projects qualify.

The committee discussed size of project as a criteria for UFC review.

Member Flanagan left the meeting at 5:00pm.

There was no public comment.

6. New Business/Future Agenda Items. (Discussion and Possible Action)

Peter Brastow will have updated criteria and guidelines for future projects at the next meeting.

Chair Lacan suggested determining an emergency response for a small scale or large scale mortality event.

There was no public comment.

7. Adjournment.

The meeting was adjourned at 5:18pm.
