MEETING MINUTES FINAL

**Tuesday, May 4, 2021, 4:00 p.m.
Remote meeting via web conference**

Order of Business

Public comment will be taken before the Council takes action on any item.

1. Call to Order and Roll Call.

The meeting was called to order at 4:05pm.

Present: Chair Igor Lacan, Members: Dan Flanagan, Nicholas Crawford, Blake Troxel. Absent: Member Andrew Sullivan.

2. Approval of Minutes of the April 6, 2021 Urban Forestry Council Planning and Funding Committee Meeting. (Explanatory Document: April 6, 2021 Draft Meeting Minutes) (Discussion and Action)

There was no public comment.

Upon a motion by Member Crawford, and a second by Chair Lacan, the minutes were approved without objection. (Ayes: Chair Igor Lacan, Member Crawford, Member Flanagan, Member Troxel. Noes: None. Absent: Member Sullivan).

3. General Public Comment: Members of the public may address the Committee on matters that are within the Committee's jurisdiction and are not on today's agenda.

There was no public comment.

4. Discussion of Acacia Tree Mortality. Speaker: Igor Lacan, Committee Chair. (Discussion)

Chair Lacan gave an overview of the Mortalitetree project that focuses on investigating increased tree mortality observed in late 2020 - now. Chair Lacan explained the progression of tree mortality throughout the Bay Area across a variety of species including Oak, Eucalyptus, Acacia and Monkeyflower.

Hypotheses include the possibility of a new pathogen, an evolving existing pathogen, environmental pressures and/or combination of these stressors (including drought/heat). Final conclusions will depend on more data collection and a broader dataset but two pathogens are speculated to be causing current disease in Acacia trees.

Follow up discussion about management strategies and how pathogen was spread.

There was no public comment.

5. New Business/Future Agenda Items. (Discussion and Possible Action)

Chair Lacan stated that results from other tree types should be available shortly as the Mortalintree project continues.

Member Crawford would like to follow up on planting and funding issues.

Member Flanagan left the meeting.

There was no public comment.

6. Adjournment.

The meeting was adjourned at 4:53pm.
