**ORDER OF BUSINESS**

**Public comment will be taken on each agenda item involving discussion or action before the Commission takes action on that item.**

**1. Call to Order and Roll Call.**

The meeting was called to order at 6:21 p.m.

Present: Commissioners Eddie Ahn, Austin Hunter, Heather Stephenson, Mike Sullivan, and Sarah Wan.

Excused: Commissioners Elmy Bermejo and Johanna Wald.

**2. Review and vote on whether to approve Resolution File 2022-03-COE, Resolution Making Findings to Allow Teleconferenced Meetings Under California Government Code Section 54953(e).**

Speaker: Kyle Wehner, Commission Affairs Officer (Explanatory Document: Resolution File 2022-03-COE) (Discussion and Action)

The Commission will discuss and consider adoption of a resolution making findings that Government Code Section 54953(e) requires in order to allow the Commission to hold meetings remotely, as currently required under local law, without complying with certain Brown Act requirements.

Public Comment: David Pilpel reported that the meeting is not being broadcast on SFGovTV. Kyle Wehner noted that the meeting is web-only until the conclusion of the Board of Education meeting. Sara Greenwald began to speak about the Climate Action Plan. Kyle noted that public comment on this item is limited to comments on the resolution.

Upon a motion by Commissioner Wan and a second by Commissioner Hunter, the resolution was approved without objection. (Ayes: Commissioners Ahn, Hunter, Stephenson, Sullivan, and Wan. Noes: None; Absent: Commissioners Bermejo and Wald)

### **3. President's Welcome.** (Discussion)

President Ahn delivered the land acknowledgment and welcomed everyone to the meeting.

Commissioner Wald joined the meeting.

Public Comment: David Pilpel reported that the meeting is not being broadcast on SFGovTV. Kyle Wehner noted the web address for the meeting feed. Sara Greenwald expressed support for additional funding for the City's Climate Action Plan.

### **4. Approval of Minutes of the March 22, 2022, Commission on the Environment Meeting.** (Explanatory Document: March 22, 2022, Draft Minutes) (Discussion and Action)

Public Comment: David Pilpel described concerns relating to the form of the draft minutes.

Commissioner Wald exited the meeting.

Upon a motion by Commissioner Hunter and a second by Commissioner Wan, the draft minutes were approved without objection. (Ayes: Commissioners Ahn, Hunter, Stephenson, Sullivan, and Wan. Noes: None; Absent: Commissioners Bermejo and Wald)

### **5. General Public Comment.** Members of the public may address the Commission on matters that are within the Commission's jurisdiction and are not on today's agenda.

Public Comment: David Pilpel said the Public Integrity Review Preliminary Assessment raised important concerns and urged commissioners to take them seriously. Elena Engel expressed concern about the status of the Department of the Environment's budget request and advocated for additional funding.

### **6. Presentation on Public Integrity Review Preliminary Assessment and Update on the Implementation of Assessment Recommendations.** Speaker: Tyrone Jue, Acting Director (Explanatory Documents: Public Integrity Review Preliminary Assessment, San Francisco Department of the Environment's Relationship with Recology and Lack of Compliance with Ethics Rules, and Letter Ending Relationship with Friends of SF Environment) (Discussion)

Commissioner Wald rejoined the meeting.

Acting Director Jue discussed the context of the Public Integrity Review Preliminary Assessment and described the Department's work to implement assessment recommendations.

Commissioner Hunter asked whether the Commission could make recommendations to the Controller's Office concerning the order and format of public hearings on the rate-setting process. Acting Director Jue said the Department will seek clarification from the Controller's Office.

Commissioner Sullivan asked about the status of a Department of Public Works order concerning the Department of the Environment's role in the rate-setting process. Acting Director Jue said it is his understanding that the order is still in place and noted the Department of Public Works could issue an additional order to provide clarity.

Commissioner Hunter noted that the Department does not produce an annual report and asked Acting Director Jue how the Department will report gifts in a manner consistent with disclosure requirements. Acting Director Jue confirmed that gifts are reported on the Department's website.

Commissioner Hunter asked whether gifts can be disclosed in the Commission's annual report. Acting Director Jue agreed that gifts and other ethics updates could be included in the annual report and featured in Director's reports throughout the year.

Commissioner Hunter suggested scheduling ethics trainings to coincide with the period preceding the Department's largest fundraising period.

Acting Director Jue described the relationship between the Department and Friends of SF Environment.

Commissioner Hunter asked whether the Department was aware of relationships between members of the board of Friends of SF Environment and other City departments or City staff. Charles Sheehan, Chief Policy and Public Affairs Officer, noted that Friends of SF Environment board members may have connections with the City and may be former City employees.

Vice President Stephenson said that ethics training should draw clear distinctions between sponsorships and gifts. Acting Director Jue and Sarah Crowley, Deputy City Attorney, noted that, per the behested payments rule, there is no distinction between sponsorships and gifts.

Commissioner Wald asked whether the Department had considered creating an ethics officer position. Acting Director Jue confirmed the Department has requested funding to create a senior position to assist with budgeting, ethics, contracts, and grant compliance. Acting Director Jue said a job description will be made available.

Commissioner Hunter asked whether the Department must receive the Commission's approval to charge fee-based tours before requesting approval from the Board of Supervisors. Acting Director

Jue said the Department will investigate this issue and noted that the Commission could set a policy requiring approval of fee-based tours before pursuing other steps in the process.

Vice President Stephenson asked what percentage of the Department's historical and present budgets would have been impacted by the behested payments rule. Acting Director Jue said he will make this information available to the Commission at a future meeting.

Commissioner Wan exited the meeting.

Kyle Wehner described the authorization requirements for budget contracts, MOUs, and grants at comparable City commissions. President Ahn asked how the commissions were selected and why the Public Utilities Commission and the Department of Public Works were not featured. Charles said the Department focused on commissions that are of an approximately similar size or engage in similar activities. President Ahn asked if the Department could identify the average size of a Department of Environment grant or contract. Charles confirmed this information will be made available.

Commissioner Wald noted that, when reviewing the Department budget, the Commission should be provided with a list of contracts and grants received by the Department. Vice President Stephenson expressed support for having this information made available on a rolling basis.

Commissioner Hunter requested that the Department provide the Commission with multiple oversight options rather than a single recommendation, and asked that commissioners have a clear understanding of how much additional work they would be taking on as a result of changes that are adopted. Commissioner Hunter asked about the Department's timeline for implementing recommendations. Acting Director Jue said the Department is committed to addressing the challenges addressed in the Controller's report as soon as possible.

President Ahn requested that the Department's response to the issues raised in the Preliminary Assessment be agendaized at future Commission meetings.

Public Comment: David Pilpel described actions the Department should take in response to the Public Integrity Review Preliminary Assessment.

## **7. Director's Report.** Speaker: Tyrone Jue, Acting Director (Discussion)

Acting Director Jue reported that the general fund request was not included in the Mayor's budget. Acting Director Jue noted that the Department remains engaged in discussions with the Mayor's Office on this issue.

Commissioner Hunter expressed his preference for an update from Acting Director Jue on his broader goals for the Department at a future Commission meeting. Acting Director Jue said the Department will make available requested information on the Department's budget at the next Commission meeting but noted that additional time will be needed to develop and present on long-term goals.

Public Comment: David Pilpel described actions the Department should take in response to the Public Integrity Review Preliminary Assessment. Sara Greenwald expressed support for the Commission's work to promote clarity and transparency at the Department.

**8. New Business/Future Agenda Items.** Speaker: Charles Sheehan, Chief Policy and Public Affairs Officer (Discussion)

Charles Sheehan reviewed the schedule for future meetings and potential agenda items.

Vice President Stephenson asked that the Commission review options for hybrid meetings.

There was no public comment.

**9. Adjournment.**

The meeting was adjourned at 8:33 p.m.

**Public Comment**

If it is demonstrated that the comments by the public will exceed 15 minutes, the President may continue Public Comment to another time during the meeting.

The Brown Act forbids the Commission from taking action or discussing any item or issue not appearing on the posted agenda. This rule applies to issues raised in public comment as well. In response to public comment, not on an agenda item, the Commission is limited to:

1. Briefly responding to statements made or questions posed by members of the public, or
2. Request staff to report back on a matter at a subsequent meeting, or
3. Directing staff to place the item or issue on a future agenda (Government Code Section 54954.2(a).)
