**2. Review and vote on whether to approve Resolution File 2022-03-COE-OC, Resolution Making Findings to Allow Teleconferenced Meetings Under California Government Code Section 54953(e).** Speaker: Kyle Wehner, Commission Affairs Officer. (Explanatory Document: Resolution File 2022-03-COE-OC) (Discussion and Action)

Public Comment: David Pilpel confirmed his audio was working.

5. **Update on the Department of the Environment Budget.** Speaker: Joe Salem, Program Manager, Finance and Administration. (Discussion)

Joe Salem presented on the Department of the Environment budget and the administration of funding awarded through the Board of Supervisors' addback process.

Commissioner Wan, Joe, and Acting Director Jue discussed funding for new positions at the Department.

Commissioner Hunter, Joe, and Acting Director Jue discussed funding for professional services and grants related to the Climate Action Plan.

Public Comment: David Pilpel identified an error in the budget presentation and discussed strategies to fund the Climate Action Plan.

6. **Presentation on Toxics Reduction Grant Program Pilot.** Speaker: Huy Le, Household Hazardous Waste and Used Oil Program Coordinator. (Discussion)

Huy Le and Minhthu Le, Commercial Toxics Reduction Assistant Coordinator, presented on the Department's Toxics Reduction Grant Program.

Commissioner Wan and Minhthu discussed whether existing grants can be renewed.

Commissioner Hunter and Huy discussed grant recipient criteria.

7. **Update on ReThink Disposables.** Speaker: Doug Streblow, Engagement Coordinator. (Discussion)

Doug Streblow provided an update on Environment Now and the Department's reuse work.

Commissioner Hunter and Doug discussed strategies for outreach to local businesses.

Commissioner Stephenson and Doug discussed resources that could help educate the public.

Commissioner Wan and Doug discussed barriers to participation among local businesses.

Public Comment: David Pilpel expressed support for the Department's reuse programs and described reservations about the use of door-to-door outreach going forward.
