ORDER OF BUSINESS

Public comment will be taken before the Committee takes action on any item.

1. Call to Order and Roll Call.

The Commission on the Environment Operations Committee meeting was called to order at 5:01 p.m.

Present: Commissioners Bermejo and Wan.

Excused: Commissioner Hunter.

2. Approval of minutes of the April 21, 2021 Commission on the Environment Operations Committee meeting. (Explanatory Document: April 21, 2021 Draft Minutes) (Discussion and Possible Action)

Upon a motion by Commissioner Bermejo, and a second by Chair Wan, the minutes were approved without objection. (Ayes: Commissioners Bermejo and Wan. Noes: None. Excused: Commissioner Hunter.)

4. Presentation on Nap Mat Swap Out Program. Speaker: Pauli Ojea, Senior Coordinator, Commercial Toxics Reduction. (Discussion)

Commissioner Bermejo thanked Pauli for the presentation. She added that it would be especially helpful for smaller childcare facilities and bringing people into the Zoom era.

Pauli said that many participants were smaller facilities and that the partners were a huge help.

Pauli said that the trainings were in English, Spanish, Cantonese, and Mandarin.

Chair Wan asked what percentage of providers were reached through this program

Pauli said that they decided to work with a subset of the partners' programs.

Chair Wan asked if the trainings are online.

Pauli said that they are.

5. Presentation on the Department of the Environment Branding Update. Speaker: Jennifer Tsang, Senior Marketing and Communications Specialist. (Discussion)

Jennifer presented on the Department's branding audit.

Chair Wan said that it would be great to clarify the Department's name and take other languages into consideration.

Public Comment

At this time, members of the public may address the Committee on items of interest that are within the subject matter jurisdiction of the Committee but are not on today's agenda. If it is demonstrated that the comments by the public will exceed 15 minutes, the President may continue Public Comment to another time during the meeting.

The Brown Act forbids the Committee from taking action or discussing any item or issue not appearing on the posted agenda. This rule applies to issues raised in public comment as well. In response to public comment, not on an agenda item, the Committee is limited to:

1. Briefly responding to statements made or questions posed by members of the public, or
2. Request staff to report back on a matter at a subsequent meeting, or
3. Directing staff to place the item or issue on a future agenda (Government Code Section 54954.2(a).)
