ORDER OF BUSINESS

Public comment will be taken before the Committee takes action on any item.

1. Call to Order and Roll Call.

The Commission on the Environment Policy Committee meeting was convened at 5:02 p.m.

Present: Commissioners Eddie Ahn, Mike Sullivan, and Johanna Wald.

2. Approval of minutes of the March 9, 2020 Commission on the Environment Policy Committee meeting. (Explanatory Document: March 9, 2020 Draft Minutes) (Discussion and Action)

Upon a motion by Commissioner Sullivan and a second by Commissioner Wald the minutes were approved without objection. (Ayes: Commissioners Ahn, Sullivan, and Wald; Noes: None; Absent: None).

There was no public comment.

3. General Public Comment. Members of the public may address the Committee on matters that are within the Committee's jurisdiction and are not on today's agenda.

There was no public comment.

4. Consider Whether to Recommend That the Commission on the Environment Approve the Proposed 2020 Reduced Risk Pesticide List for City properties. Under the Environment Code, the Department maintains a Reduced Risk Pesticide List identifying those pesticides that may be used on City

property, subject to restrictions. Sponsor: Deborah Raphael, Director; Speaker Dr. Chris Geiger, Integrated Pest Management Program Manager (Explanatory Documents: Staff Memo, Resolution File No. 2020-03-COE, 2020 Reduced Risk Pesticide List) (Discussion and Possible Action)

Director Raphael introduced this agenda item.

Chris Geiger, Integrated Pest Management Program Manager, presented on the background of the integrated pest management program and ordinance, pesticide use trends for 2019, and recommendations to the Commission on the reduced risk pesticide list.

Luis Agurto, Pestec, spoke about the impacts from the pandemic on staff and services as well as device upgrades that are currently in progress.

Kevin Woolen, San Francisco Public Utilities Commission, gave an overview of common pest issues, impacts of COVID-19 on activities, and wildfire monitoring.

Matt Pruitt, San Francisco Recreation and Parks Department, spoke about pandemic impacts on indoor facilities, decreased labor forces, and persistent pest challenges. He also spoke about the Department's pesticide reduction trends.

Chris Geiger gave a summary of the proposed changes to the reduced risk pesticide list and the reasoning behind the changes.

Commissioner Ahn thanked the speakers for joining the meeting.

Commissioner Sullivan asked what Weedslayer would be used for and which products it would be replacing.

Matt Pruitt said that Weedslayer could replace Roundup because it treats weeds that have storage, but Weedslayer is still experimental.

Commissioner Sullivan asked what the timeline is for using Weedslayer to replace some chemicals.

Matt Pruitt said that his department will look for opportunities to substitute glyphosate and other tier 2 herbicides.

Commissioner Sullivan mentioned that he would be supportive of a Commission letter in support of dry ice as a rat control product.

Commissioner Wald mentioned that the pesticide use trends are very commendable and San Francisco residents should feel proud. She thanked Matt Pruitt for addressing the maintenance loop issue. Commissioner Wald then asked if there will be an increase in pesticide use next year because of COVID-19 impacts on services.

Chris Geiger stated that he assumes there will be an increase in pesticide use due to reductions in staff and other impacts.

Matt Pruitt agreed that there will most likely be an increase due to reductions in volunteers.

Luis Agurto mentioned that they received an exemption for a rodenticide, but that work was affected by the pandemic.

Commissioner Wald asked Chris Geiger to mention this potential increase due to reasons beyond our control in comments to the Commission. She added that she would also support a letter regarding dry ice as a rat control product.

Commissioner Ahn stated that he would also be in support of a letter regarding dry ice as a rat control product and that it should be brought up before the full Commission.

Commissioner Wald recommended that two letters be sent to Bell Laboratories and the EPA. She would also like to potentially work with other California cities and other states to show Bell that there is a market for this product.

Chris Geiger agreed that this would be a good strategy and mentioned that the Department has partners who would be likely to sign on as well.

Commissioner Ahn asked if there are additional questions.

Director Raphael asked if the Public Utilities Commission has seen increases in herbicide use after fires.

Kevin Woolen responded that it is hard to know what the impacts will be because the focus has been on emergency response.

Director Raphael added that there should be a way to indicate any impacts from COVID-19 or wildfires on next year's dataset. She then asked what had caused the reduction in Pestec's time spent at affordable housing sites.

Luis Agurto stated that this was due to COVID-19 and restrictions on non-emergency services.

Commissioner Wald asked to hear from members of the public before continuing any discussion.

There was no public comment.

Upon a motion by Commissioner Sullivan and a second by Commissioner Wald the motion was approved without objection. (Ayes: Commissioners Ahn, Sullivan, and Wald; Noes: None; Absent: None).

Commissioner Ahn mentioned that the letters in support of dry ice as a rat control product should be brought up at the full Commission meeting.

5. **Director's Update.** Deborah Raphael, Director (Discussion)

Director Raphael gave an update on the Commission letter sent to Supervisor Mandelman's office regarding the all-electric new construction ordinance. She also mentioned the budget hearing before the Board of Supervisors, the W Challenge celebrating the ratification of the 19th Amendment, and a presentation to Department staff from Jeff Tumlin, Director of SFMTA. Looking ahead, Director Raphael mentioned upcoming topics for the Commission meetings including the Department's racial equity, the City's economic recovery plans, and the impending office move.

Commissioner Sullivan asked if the Department would be saving money by not having an office for a few months.

Director Raphael confirmed that the Department's lease in the new office building will begin immediately.

Commissioner Ahn mentioned that engagement on transit issues will be very important.

There was no public comment.

6. New Business/Future Agenda Items. Charles Sheehan, Chief Policy and Public Affairs Officer (Discussion)

Charles Sheehan mentioned the upcoming Commission meeting on September 22, Operations Committee meeting on October 21, and the Policy Committee Meeting on October 26. He also mentioned the sustainable consumption report which will be brought before either the Policy Committee or the full Commission.

7. Adjournment.

The meeting was adjourned at 6:33 p.m.

The next meeting of the Commission on the Environment Policy Committee is scheduled for Monday October 26, 2020, at 5:00 p.m. In compliance with the San Francisco Health Officer's Order No. C19-07c, directing all individuals to "shelter in place", Public meetings, panels and other advisory bodies will continue on a remote conferencing basis only.

1. Briefly responding to statements made or questions posed by members of the public, or
2. Request staff to report back on a matter at a subsequent meeting, or
3. Directing staff to place the item or issue on a future agenda (Government Code Section 54954.2(a).)
