- 1. Call to Order and Roll Call.** The meeting was called to order at 4:07 p.m. Members Lacan, Flanagan, Sullivan and Swae were present.
- 2. Approval of Minutes of the October 4, 2016 Urban Forestry Council Planning and Funding Committee Meeting.** (Explanatory Document: October 4, 2016 Meeting Draft Minutes) (Discussion and Action)

Member Flanagan moved to approve the meeting minutes and Member Sullivan seconded. The meeting minutes were approved without objection.

**4. Presentation on the Natural Resource Management Plan.** The Recreation and Park Department will present an update on the Natural Resource Management Plan. Speakers: Lisa Wayne, Natural Resources Manager, San Francisco Recreation and Park Department (Discussion)

Lisa Wayne, Natural Resources Manager, San Francisco Recreation and Park Department, discussed the history of the management plan, the draft EIR in 2015, the scope of the natural areas, biodiversity within the natural areas, the value of trees and the urban forest, condition of eucalyptus, the health of biological diversity, the urban forest at Mount Davidson, tree and forestry recommendations, tree and urban forest protection, forestry management recommendations, thin tree is biologically diverse areas, impacts of eucalyptus, proposed thinning in basal areas and SNRAMP EIR assessments.

Member Flanagan asked about the tree quality assessments in the EIR and how it relates to the trees on Mount Sutro.

Member Sullivan asked about how many acres in the natural areas will be preserved, the total forest cover of San Francisco, evaluations of density and how cultural value of a forest to the community is factored into the process.

Member Flanagan asked about removals and the use of herbicides.

Member Sullivan asked about whether or not additional details will be added to the management plan, the timeline of the plan and whether or not details about funding will be added to the plan.

Member Lacan asked about the goals for the MA1 and MA2 areas, plans for tree replanting in these areas and tree removal in Mount Davidson.

Member Swae asked about examples other than Glen Canyon for areas that have transitioned from eucalyptus to natural areas, whether or not any amendments have been made to the plan since 2006 and phasing of tree removal.

Member Flanagan asked about 1 to 1 tree replacement in terms of caliber of the tree.
