# **Order of Business** Public comment will be taken before the Council takes action on any item.

1. Call to Order and Roll Call.

The meeting was called to order at 4:06 PM Present: Lacan, Flanagan, Troxel, Crawford, Sullivan (the latter two both arrived after items 2 and 3).

2. Approval of Minutes of the August 6, 2019 Urban Forestry Council Planning and Funding Committee Meeting. (Explanatory Document: August 6, 2019 Draft Meeting Minutes) (Discussion and Action)

Upon a motion by Member Troxel and a second by Member Flanagan, the meeting minutes were approved without objection. (Ayes: Members Igor Lacan, Dan Flanagan and Blake Troxel. Noes: None.) There was no public comment.

3. Approval of Minutes of the October 1, 2019 Urban Forestry Council Planning and Funding Committee Meeting. (Explanatory Document: October 1, 2019 Draft Meeting Minutes) (Discussion and Action)

Upon a motion by Member Flanagan and a second by Chair Lacan, the meeting minutes were approved without objection. (Ayes: Members Igor Lacan, Dan Flanagan and Blake Troxel. Noes: None.) There was no public comment.

**4. General Public Comment:** Members of the public may address the Committee on matters that are within the Committee's jurisdiction and are not on today's agenda.

Lance Karns commented about Bureau of Urban Forestry (BUF) tree removal practices, data management and tree survey.

Zack Karnazes discussed getting disability accommodations for tree removal notices.

Josh Klipp, accessibility consultant, discussed notices being more accessible, an update to Article 16 of the Public Works Code, 1140 Harrison, and the Supervisor Mar hearing.

5. Discussion on material reuse and the 2019 Urban Wood Academy. Speakers: Jon Swae, Principle Analyst, Bureau of Urban Forestry, Department of Public Works and Eden Brukman, Senior Green Building Coordinator (Discussion)

The speakers reported on the USFS/City of Baltimore 2019 Urban Wood Academy that took place in Baltimore. They discussed the ideas around salvaging urban trees and wood, including trees cut down in the streets or parks (fresh cut) and deconstructed wood from buildings.

Committee members raised various questions and comments and a healthy, lengthy discussion ensued with the presenters, including about the idea of holding a summit in San Francisco on the topic of urban wood.

#### **Public Comment:**

Josh Klipp discussed how urban wood reuse is already happening, so let's build on it, and what can be done with the ficus trees.

Susan Karasoff of CNPS-Yerba Buena Chapter discussed planting native trees and thanked the presenters for their efforts.

6. Discussion on implementation of the Urban Forestry Council Strategic Plan. Speaker Igor Lacan, Committee Chair (Explanatory Documents: Strategic Plan Member Assignment and UFC 2019 Strategic Plan) (Discussion)

Chair Lacan discussed the progress to date on implementation of the 6 goals/priorities from the Strategic Plan.

Peter Brastow updated on Goal/Priority #2 and the pursuit of LiDAR data for the City and pointed out that we need money in order to pay for the overflight. Members Flanagan and Lacan supported making incremental progress on this particular item.

The Committee discussed the process of reporting, the periodicity, the format etc.

Member Flanagan discussed progress on Goal/Priority #6 and moving people from "co-lead" to "lead" on the table of commitments.

Member Crawford underscored the utility of the Planning and Funding Committee for reporting on implementation, and the committee confirmed that they would

Josh Klipp discussed entities (Planet Labs) that have already collected (LiDAR) data, and that they could be tapped.

Susan Karasoff expressed appreciation for the adding of native plants to the street tree list and discussed Google and Microsoft as data sources.

7. Review and vote on whether to recommend that the full Council support Resolution File No. 2019-07-UFC regarding the federal Climate Stewardship Act. Speaker: Peter Brastow, Urban Forestry Coordinator, Department of Environment (Explanatory Document: Resolution File No. 2019-07-UFC Climate Stewardship Act) (Discussion and Action)

Peter Brastow discussed the item, including some excerpts from the urban forestry sections of the draft federal bill.

Member Troxel discussed meeting with American Forests representatives at a recent conference and that they were inquiring about San Francisco's endorsement.

Committee discussed the issue of the cost of planting urban trees versus in a rural context, and that the points should be made in the resolution.

Committee discussed the multiple human benefits (besides sequestration and biodiversity) of planting urban trees, and of incorporating the point in the resolution.

Peter Brastow proposed drafting two more clauses for the resolution.

Upon a motion by Chair Lacan and a second by Chair Crawford, the recommendation to the Full Council to take up File No. 2019-07-UFC was approved without objection. (Ayes: Members Igor Lacan, Nick Crawford, Andrew Sullivan and Blake Troxel. Noes: None. Member Flanagan left at the end of #6) There was no public comment.

# 8. New Business/Future Agenda Items. (Discussion and Possible Action)

Peter Brastow, Urban Forestry Coordinator, and committee members discussed upcoming agenda items, including the Strategic Plan, Chair's Welcome, Climate Stewardship Act and Public Works annual update at the Full UFC on 12/13, also the status of the Moreton Bay Fig at the Bernal Campus, the Carbon Fund, Urban Forest Master Plan: Phase III update, tree diseases, Street Tree nursery at I-80, annual report format, 3333 California Street, Geary and Van Ness BRT, the pipeline of development agreements.

Member Crawford spoke to the role of the Council vis-à-vis the Board of Supervisors, that the UFC agenda is the place to discuss UF issues and then bring info on those to the Board.

## **Public Comment:**

Josh Klipp commented on 3333 California Street and people lining up at the City Hall hearing to say save trees; supporting the Supervisors; and the street tree nursery.

Chair Lacan expressed thanks for Anthony Valdez' service and to Peter Brastow for his work supporting the Council.

#### 9. Adjournment.

The meeting was adjourned at 5:54 p.m.
