**4. Presentation on Draft San Francisco Net Zero Emissions Pathway Report.** Sponsor: Deborah Raphael, Director; Speakers: Wendy Goodfriend, Climate Program Manager. (Discussion)

Charles Sheehan, Chief Policy and Public Affairs Officer, introduced the item in Director Deborah Raphael's absence.

Wendy Goodfriend, Climate Program Manager, discussed the draft San Francisco Net Zero Emissions Pathway Report including San Francisco's Global Climate Action Summit commitments,

success to date – growth without emissions, current emissions by sector, a pathway to net-zero emissions, pathway analysis – key findings, 2030 is a pivotal year, energy commitments, energy actions, comparing sectors, transportation commitments, transportation actions, various scenarios, building commitments, building actions, path to net zero and next steps.

Commissioner Ahn asked if there will be annual metrics.

Commissioner Wald asked when the next steps will be completed so the strategy can be updated and whether other local jurisdictions are as comprehensive as San Francisco in reducing emissions.

Silvia Pac, Climate and Sustainability Analyst, discussed San Francisco's Municipal Progress Report including the Department Climate Action Plans setting the foundation, refresh and relaunch, reengaging City departments, relaunching new core program activities, municipal progress report, municipal emissions, facility emissions, non-revenue fleet emissions, emissions by department, 0-80-100 Roots, connection between programs and climate goals, broader benefits of programs, City ordinances, summary of achievements, challenges, actions, tips for individuals and the year to come.

Commissioner Wald asked which agencies did not participate in the agency roundtable and recognizing City agencies who are moving the ball forward on emissions reduction.
