3 **Resolution approving Department of the Environment Funding Recommendations for Zero**
4 **Waste grant awards to fourteen organizations in grant cycle period (FY 2021– 2023)**

5 WHEREAS, The Zero Waste program of the San Francisco Department of the Environment
6 provides grant funding to non-profit groups; and,

7 WHEREAS, Zero Waste grants are dedicated to funding projects that reduce consumption and
8 recover material from San Francisco’s landfill, thereby assisting the City in achieving its goal of zero
9 waste; and,

10 WHEREAS, in addition to helping San Francisco reach its zero waste goals and in keeping with
11 the Department’s commitment to equity, these grant funded projects achieve a range of co-benefits such
12 as creating jobs, providing youth development activities, recovering edible food for low-income San
13 Franciscans, engaging non-English speakers in zero waste practices, and building community; and,

14 WHEREAS, other crucial co-benefits include providing re-use materials for youth development
15 programs and San Francisco’s small businesses, contractors, and arts community; and,

16 WHEREAS, working towards a zero waste economy while supporting San Francisco’s diverse
17 communities through these grants will promote equitable recovery from the COVID-19 pandemic; now,
18 therefore, be it

19 RESOLVED, the Commission approves the award of Zero Waste grants, totaling \$1,031,000 to
20 be disbursed during FY 2021-2023 to the following organizations:
