

Zero Waste Facilitators: A Proven Recovery Solution

Hiring a Zero Waste Facilitator can help property managers in San Francisco lower refuse costs, prevent contamination charges, and maintain compliance with the City's Mandatory Recycling and Composting Ordinance. Zero Waste Facilitators can assist both commercial and residential properties with material recovery by aiding in back-of-house sorting of materials, providing education and feedback to tenants and staff to improve participation, improving collection efficiency, preventing valuable materials from ending up in the landfill, and reducing contamination in composting or recycling.

The companies listed below are currently offering Zero Waste Facilitator services in San Francisco. This list may not include all companies providing such services, and buildings that must hire a Zero Waste Facilitator per City law are not required to hire off this list.
